## The Dog Exclusion (Blackburn with Darwen ) Order 2013

Blackburn with Darwen Borough Council hereby makes the following Order:

- 1. This Order comes into force on the 1st April 2013
- 2. This Order applies to the land specified in Schedules attached

#### Offence

- 3. (1) A person in charge of a dog shall be guilty of an offence if at any time he/she takes a dog onto, or permits a dog to enter or to remain on, any land to which this order applies unless
  - (a) He has a reasonable excuse to do so; or
  - (b) The owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his doing so
  - (2) Nothing in this article applies to a person who
    - (a) is a registered blind person in a register compiled under section 29 the National Assistance Act 1948; or
    - (b) is deaf, in respect of a dog trained by Hearing Dogs for Deaf People and upon which he relies for assistance; or
    - (c) has a disability which affects his/her mobility, manual dexterity, physical co-ordination or ability to lift, carry or otherwise move everyday objects, in respects of a dog trained by a prescribed charity and upon which he/she relies for assisitance
  - (3) For the purpose of this article -
    - (a) a person who habitually has a dog in his possission shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog; and
    - (b) each of the following is a "prescribed charity" -
    - (i) Dogs for the Disabled (registered charity 700454)
    - (ii) Support Dogs Ltd (registered charity 1088281)
    - (iii) Canine Partners for Independence (registered charity 803680)
    - (iv) Hearing Dogs for Deaf People (registered charity 293358)

(v) Guide Dogs for the Blind Association (registered charity 209617)

# Penalty

4. A person who is guilty of an offence under article 3 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.
